<u>High School Gym Floor-</u>The gym floor has flattened out and is able to be used, and this summer it need to be repaired. The majority of the costs (if not all) associated with the repair will be covered by our Insurance.

<u>Substitute Teacher Rate-</u>Mrs. Filyaw discussed increasing our substitute teacher rate, as we have had the same amount for 5-8 years.

Illinois Department of Transportation Appraisal. Land Purchase and Easement- Mrs. Filyaw provided an update regarding the IDOT proposal to purchase the land and easement. There is a meeting with the appraiser the day after the board meeting.

<u>Chromebook Usage-</u> Mrs. Filyaw discussed gathering data to determine the amount the chrome books are being used in the classrooms. The plan is to collect data a week in February, and a week in March. Administration will then tabulate this information and report to the board in April.

# Health/Life/Safety Audits

Mrs.Filyaw attached documents at the meeting from the Health/Life/Safety audits that were completed in the district earlier this school year by ROE and the Fire Marshal. As discussed, there are a few items that will need to be fixed/replaced this summer.

## F. Principals' Report

Mr. Huels stated that there was fantastic growth from the Fall to Winter benchmarking on AlMSweb, and iReady. 356 students earned candy for making progress on their AlMSweb benchmark test, which is 73% of our total student population. 298 students earned a soda for meeting their growth goal on their iReady diagnostic test, which is 61% of our student population. Also, Mr. Huels wants to send a 'Thank you' to Mr. Brokering and coaches for a successful turnout to the Cancer Basketball Game, which raised over \$1,000.

Mr. Weathers wants to Congratulate the 83 Winter Challenge winners, who received an Ice Cream party. He adds that the Vending Book Machine at New Baden Elementary earned 100 books in 3 months. Also, Mr. Weathers wants to thank the custodial staff for cleaning the buildings over Christmas break, and after all of the Little Warrior games.

Mr. Rahm wants to thank Kevin Brinkeman, who donated \$2,000 to the Vocational class for tools. He adds that he wants to thank the custodial staff for cleaning after the MLK tournament held at the High School. A big Congratulations to Luke Davis- who was nominated for the National Society Scholars award.

Mrs. Woll wants to congratulate Mrs. Barton's 3rd Grade class for their success with the dollar days program. There is a charity chosen to donate to, along with a donation to Clinton County Cancer Organization and a donation to the food pantry.

#### II. Public Comments:

She states that it does not collect data from the chromebooksonly the search engine, and during school hours only. She also stated that the school can set to parent notification only as a default setting, should there be an worries about the tracking or data that is being reviewed.

A. Trenton Tax Increment Financing District Extension

# B. Federal Impact Aid Submission

The Impact Aid Program is designed to directly compensate local school districts for costs incurred due to "federally connected" students, such as the children of armed services personnel working at a nearby military base. Unlike most other forms of educational assistance, Impact Aid disburses roughly \$1.2 billion annually in the unrestricted federal funds directly to local school districts rather than through state agencies.

Last year the district submitted for impact aid, and will be receiving about \$10,000.00. We are surveying the parents and anticipate that the district will again meet the 4% threshold and can apply for assistance. The district is completing the application and the board must approve the submission.

- Enrolled in an in-person college class during the school day
