Jared Poettker recommended a flat \$115.00 for all substitutes across the board. He stated that it was not feasible to pay retired teachers more than regular substitute teachers.

Dustin Biggs questioned whether the pay was higher or lower if the substitute teacher had a degree.

Tina Litteken stated that she agreed with the retired teachers getting more pay as they are teachers who are experienced and know the routine and/or students.

Connie Elmore stated that she would rather see a \$10.00 difference between the pay for retired Wesclin teachers who are substitute teachers in our district.

Motion by _Tina Litteken_ seconded by _Connie Elmore_ to set our substitute teacher pay at \$115.00 per day. Retired Wesclin Unit School District Teachers will be paid \$125.00 per day.
